

## COVID-19 Facility Waiver of Liability

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact, including individuals without disease symptoms. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited or limited the congregation of groups of people.

The health and well-being of our staff and athletes remains our top priority. In order to minimize the risk of COVID-19 entering our environment and spreading amongst our community, we will only allow staff assigned to work and athletes scheduled to participate to be in our gym.

Furthermore, all participants in sponsored activities at Spiral Sports Complex must agree to and abide by the following:

Requirements prior to EVERY practice:

1. Athletes and coaches will be permitted to enter the facility 10 minutes prior to their scheduled practice time.
2. No one will be permitted entry into a Spiral facility if they are sick or have a family member who is sick.
3. All athletes and coaches will have their temperature taken everyday upon entry; anyone registering a temperature of 100.4 F will be denied entry into the facility. One coach will be assigned to take all temperatures.
4. All athletes and coaches will sign in everyday for contact tracing. One coach will be assigned to sign in everyone entering the facility.
5. All athletes and coaches are required to wash their hands after temperature and contact tracing sign in is completed.
6. All athletes will be required to bring a signed waiver prior to the first practice.

During practices:

1. Spectators (parents, siblings, friends) will not be permitted to watch practices.
2. Hand washing is required for athletes and coaches during each water break. This should be done in small groups to encourage social distancing.
3. No "high fives" between athletes and/or coaches.
4. No spitting on the floor to help with shoe traction.
5. Water fountains will not be available for use. Athletes and coaches must bring their own water to practices.

After practices:

1. Transportation for athletes must be available immediately following the conclusion of each practice.
2. All volleyballs will be disinfected by coaches with an antibacterial solution.
3. All facility floors will be cleaned and disinfected by Spiral prior to the next practice.

Spiral Sports Complex (hereafter referred to as "SSC") has put in place numerous preventative measures and enhanced cleaning protocols to reduce the likelihood of spreading COVID-19 in SSC's gym environment; however, the SCC cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending sponsored activities at SCC could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily agree to the participation terms described above and assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending activities at SCC and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

I understand that the risk of becoming exposed to or infected by COVID-19 at SCC may result from the actions, omissions, or negligence of myself and others, including, but not limited to, SCC employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at SCC or participation in SCC programming ("Claims").

On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless SCC, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of SCC, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any SCC activity.
